About the Organization

Lake Shore Gold, a subsidiary of Pan American Silver, is located in Timmins, Ontario. The Timmins West mine is located approximately 18 kilometers west of Timmins, Ontario, one of the world's most prolific gold camps. Mineralization is associated with the Porcupine-Destor fault system within the Abitibi greenstone belt. The Timmins West mine is comprised of the Timmins deposit, the Thunder Creek deposit, and the 144 Gap deposit. All three deposits are interconnected by underground drifts.

About the Opportunity

We are looking to hire a **Mine General Foreperson** (Mine Captain) to join our **Timmins West Mine** in **Timmins, ON.**, on a **full-time basis**. The schedule for this position is 4 on, 3 off (Monday – Thursday or Tuesday – Friday), 10 hours/day.

Please note that this role requires relocation to the Timmins area and is not a camp-based position.

In this role, you will be responsible for day-to-day scheduling and controlling the functional mine site development and construction activities in a safe and efficient manner. Direct mine operations through front-line supervisors. You will demonstrate the core values of Safety Health and the Environment and Code of Conduct of Lake Shore Gold.

- Day-to-day scheduling and control of the functional mine site development and construction activities
- Plan and organize all rehab work underground according to Engineering recommendations
