This role will play an important role in managing legal risk and supporting operational and corporate business objectives. The candidate will become a member of our global legal team supporting our operations in Canada, Mexico, Peru, Brazil, Bolivia, Chile and Argentina.

This role will be part-time and based in Toronto, Ontario.

### **Major Responsibilities:**

- Support the Ontario operations in compliance with applicable legislation, including the Environmental Protection Act, Occupational Health and Safety Act, and Endangered Species Act.
- Support the corporate legal team on a variety of matters, including corporate and commercial law matters.
- Provide assistance on legal matters relating to our Toronto office.
